Pursuant to Assembly Bill 361 and its requirements, consider and approve a motion stating that in light of the ongoing governor-declared state of emergency due to the COVID-19 pandemic, meeting in person would present imminent risks to the health and safety of attendees; and, that the Board hereby authorizes virtual meetings for the next 30 days, pursuant to AB 361.

required to unmute their microphone when commenting. Those participating by telephone may comment during the designated public comment period by pressing *9 on the keypad to indicate such interest. Commenters will be prompted to press *6 to unmute their telephone when called upon to speak. During this period of working to reduce the potential for COVID-19 transmission, CCRB will use best efforts to swiftly resolve requests for reasonable modifications or accommodations for individuals with disabilities, consistent with the Americans with Disabilities Act, and will resolve any doubt whatsoever in favor of accessibility.
